Property Description: Well-established certified organic grazing for cattle, land is mostly put into a non grain organic forage for the cattle. Plenty of room for feed storage. Land is certified organic, currently milking 180 organic milk cows. Property is located in two separate tracts and selling as a total unit. Cows, feed and machinery could be negotiated with the Seller.






#### **Location Map**
