The house is a one-story, ranch-style, single-family dwelling constructed about 1975 with approximately 960 sq ft of living area, minimal finished basement area (240 sq ft), an attached garage (308 sq ft), and porches (open slab porch). The residence is of frame construction with vinyl/metal siding, warmed and cooled mechanical systems, and a 2022 reroof. Seller has never lived in the home, selling the house for an estate, selling as is, no repairs will be made.

Hesston is a small community, a 30-minute drive north of Wichita, that blends a quiet, family-oriented atmosphere with solid regional services.
