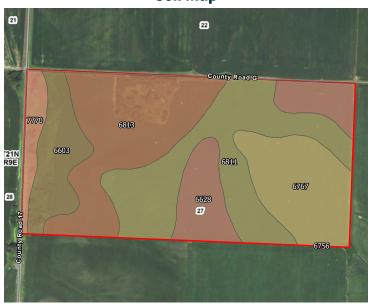
#### **Property Location**
